1. **PAYMENTS: We accept all major credit cards**, call office (209) 688-6918 to make payment. Make checks payable to: **San Joaquin Tamale Festival**. A \$35 charge is assessed for returned checks and/or declined credit cards. Full payment is due on or before September 22, 2017. An additional \$100 late fee will be added to any balance after September 22, 2017. Balances not paid by September 22, 2017 will forfeit all exhibit space and monies paid. **NO EXCEPTIONS.**
2. **CALIFORNIA RESALE LICENSE:** Vendors are responsible for including a copy of their CA Resale License number, this is a must and those who do not comply will not be able to set-up at event until the proper paperwork is filed.
3. **ADDITIONAL FEES:** A \$199 charge will be assessed for General Liability insurance coverage on October 14-15, 2017 should the proper forms not be received into the P.O. Box 782, Lathrop, CA 95330.
4. **YOUR LIABILITY:** Vendor shall be solely responsible for any and all injuries to persons or damages of property or any other injury, claim, damage or loss of whatever nature, arising directly or indirectly from activities at the Festival. Vendor shall indemnify, save, and hold harmless the Event, Anthony and Guadalupe Quilpa, San Joaquin Tamale Festival, LLC, its sponsors, San Joaquin County Fairgrounds, their employees, agents and volunteers from and against all liability, loss, damages, claims, costs and expenses (including attorney fees) arising out of injury to person or damages to property or any other injury, claim, damage, loss, cost or expense arising from activities at the Festival. The Event, Anthony and Guadalupe Quilpa, San Joaquin Tamale Festival, LLC, its sponsors, San Joaquin County Fairgrounds, 1658 S. Airport Way, Stockton, CA 95206, their employees, agents and volunteers are not liable for lost, damaged or stolen vendor property.
5. **REFUNDS & CANCELLATIONS:** Cancellations must be given in writing before the September 22, 2017 payment due date. Any amount over 50% is not-refundable. The refund will be via a check within thirty days of notice. There are no refunds or credits given after September 22, 2017. There will be no refunds for rain or other act, either man-made or natural.
6. **FESTIVAL SECURITY:** Security will be available overnight. You are advised to secure your space with tarps/clamps or other coverings and/or take items of value out of your space.
7. **SETUP & BREAKDOWN:** All vendors must set-up Thursday Oct 12, 2017 4:00 p.m. to 8:00 p.m. and Friday, Oct 13, 2017 at 8:00 a.m. 7:00 p.m. Saturday, Oct 14, 2017 at 7:00 a.m. to 9:00 a.m. If you have to restock your booth during the event you will need to use a hand cart or other means of transporting items to booth. Breakdown of your booths is allowed after 8:15pm on Sunday, October 15, 2017, anyone not in compliance may not be considered for future events. **BOOTHS MUST BE STAFFED AT ALL TIMES.**
10. **FULL INFORMATION PACKETS:** Vendors will be able to pick up participant packets at Festival.
11. **ICE:** *Vendors are NOT allowed to bring in outside ice, we will be selling bags of ice at the festival for a reasonable price.*
12. **CONFIRMED VENDORS:** Vendors are not fully confirmed until all payments and documents are received by the San Joaquin Tamale Festival. **A vendor may not set up at the Festival until all criteria is met.**
13. **VENDOR ACCEPTANCE & PLACEMENT:** Space cannot be guaranteed. However, applications received with full payments and forms, will have priority. Only a limited number of vendors in any one category will be accepted. Decisions are based on, but not limited to, history, booth appeal and available space. We reserve the right to refuse any vendor.
14. **ENFORCEMENT:** Decisions are made by Anthony and Guadalupe Quilpa, of the San Joaquin Tamale Festival, LLC, and they will be final.
15. **PROMOTIONAL GIVEAWAY ITEMS:** Hats, T-Shirts and all beverages (including water) are sold at the Festival. You may not give these items away. **We require prior approval for promotional giveaway items.**
